# **COOKIE POLICY**

#### 1 COOKIES AND SIMILAR TECHNOLOGIES

Swedfund International AB, reg.no. 556436-2084 ("Swedfund", "us", "we" or "our") use cookies and other similar technologies (jointly called "Cookies") on our website to enhance your experience with us. Cookies are small text files with information that is stored on your computer, mobile or other device used for visits to our website.

The purpose of this cookie policy (this "**Policy**") is to inform you about the collection and use of Cookies when browsing our website.

Our use of Cookies may include processing of personal data, e.g. through the collection of your IP address. For more information on our processing of your personal data in relation to Cookies, please see our <a href="Privacy Notice">Privacy Notice</a>.

#### 2 WHICH TYPES OF COOKIES DOES SWEDFUND USE AND WHY?

Swedfund uses different types of Cookies to ensure the basic functionality of our website and to analyse the use of our website.

The Cookies will be stored for different periods of time depending on the type of Cookie and its purpose. For example, so-called session cookies last throughout the session, meaning they expire when you leave the website. However, persistent cookies are stored in your browser's cookie folder until they are deleted, as they enable us to recognise you and remember your settings on our website.

Generally, we categorise the Cookies and their use as follows:

#### **Essential Cookies**

Essential Cookies are required for the basic functionality of our website, such as to administrate our cookie banner and to provide other essential services. The website cannot function correctly without these cookies.

### **Analytics Cookies**

With your consent, we also use Analytics Cookies to provide comprehensive analytical information regarding your use of our website. Analytics Cookies is a type of Non-essential Cookies.
